



## March Highlights

In Rhode Island, the Governor has submitted the budget. As with everything else in these COVID-19 related times, the Governor's budget is different this year. The budget is much smaller and contains less programmatic initiatives. However, keep in mind that this budget was developed in a noticeably short time frame, and was submitted prior to the federal government passing a stimulus package that provides assistance to state and local governments. That said, it does lay out a basis for the start of the budget discussion.

National Legislation saw success as President Biden signed the American Rescue Plan. The package sends millions of Americans \$1,400 stimulus checks, extends unemployment insurance and provides additional feeding assistance benefits.

### National Legislative Updates At A Glance:

- President Biden signed the American Rescue Plan into law Thursday following the House passage of the bill on Wednesday. Highlighted below are of the provisions of interest to our industry.

- Increases the amount states can provide in cash value vouchers (CVV) to WIC participants.
- The bill also provides an additional \$390 million in funding for WIC program modernization.
- The bill also extends P-EBT authorization beyond the 2020-2021 school year to anytime there is a federal health emergency declaration.
- Extends the 15% increase in SNAP benefits through the end of fiscal year 2021.
- Creates a program to provide funds to shore up the most critically endangered multiemployer plans for 30 years.
- The bill also provides some temporary relief for plans that suffered financial setbacks due to the COVID pandemic that should help keep them at their current funding status.
- The legislation includes \$7.5 billion directed towards the CDC to boost vaccine distribution, administration, tracking and promotion
- The bill also allocates \$47 billion to HHS to detect, diagnose, trace, and monitor COVID-19 infections, and for other activities necessary to mitigate the spread of COVID-19
- On Tuesday, the House passed the Protecting the Right to Organize (PRO) Act (H.R. 842) by a 225 – 206 vote. The legislation represents the broadest expansion of organized labor rights in over 50 years.
- This week, Democrats in both chambers unveiled separate plans that tackle just some of their key infrastructure priorities

## RI Legislative Updates At A Glance:

- **House Hearings of Note:**
  - H.5261, An Act Relating to Labor and Labor Relations – Fair Employment Practices, requires employers to adhere to equal pay for “comparable” work.
  - H.5584, An Act Related to Labor and Labor Relations – Unlawful Employment Practices, bars employers from asking potential employees for salary history before an offer of employment has been negotiated.
  - H.5718, and H.5853 Acts Relating to Labor and Labor Relations – Fair Employment Practices, forbid an employer to require an employee, as a condition of employment, to execute a nondisclosure agreement or an agreement with a clause that requires alleged violations of civil rights remain confidential, or a non-disparagement agreement concerning alleged violations of civil rights or alleged unlawful conduct.
  - H.5852, An Act Relating to Labor and Labor Relations – Fair Employment Practices, prohibits an employer, from directly or indirectly committing any act declared to be an unlawful employment practice.

The American Rescue Plan Act (ARPA), which is the latest bill to address the ongoing economic impacts of COVID-19, has been signed into law. ### Employee Retention Credit Available for Businesses Financially Impacted by COVID-19

The Employee Retention Credit (ERC) was introduced in March 2020 by the CARES Act. The Consolidated Appropriations Act, 2021 (CAA) both retroactively modified the original ERC and introduced a new ERC effective January 1, 2021. The CAA changes increase the amount of relief available and the types of eligible businesses.

While these changes present greater benefits to more employers, it's important to remember that we still have no formal IRS guidance in this area. Tax planning involving these provisions should be done with caution and in consultation with your tax preparer.

## COVID-19 Vaccine Considerations for Employers

Now that COVID-19 vaccinations are becoming more readily available across the country, employers are considering how to move forward with developing a vaccine game plan for their business and employees. While the Food and Drug Administration (FDA) has granted Emergency Use Authorization (EUA) for the Moderna and Pfizer vaccinations, indicating they are safe for use, many employees are hesitant to be vaccinated when they are eligible to receive them. This leaves employers asking what they can do to ensure safety in the workplace while addressing the fears and concerns of their employees.

## Did you know the American Rescue Plan Contains Employment Related Provisions?

The law not only provides financial relief, it contains the following measures of interest to employers and employees:

- A subsidy for COBRA premiums, funded through employer tax credits
- Extension of employer tax credits for FFCRA employee leave voluntarily provided through SEPteMBER, 30 2021
- Expansion of employee earnings eligible for the FFCRA tax credit
- INclusion and immunization as reason for FFCRA leave
- ExentSION of \$300 increase in weekly unemployment benefits
- Expansion of subsidy for ACA premiums
- Increase in DCAP contribution limits
- Extension and expansion of the employee retention tax credit

### CPGs Assert Need to Protect Stressed Supply Chains

Following the pandemic's exposure of major cracks in the nation's supply chains, the Consumer Brands Association (CBA) and the Council of Supply Chain Management Professionals (CSCMP), together with researchers from Iowa State University, have issued a report offering policy recommendations to bolster private-sector supply chains. The study calls for the establishment of a national Office of Supply Chain to provide expertise, facilitate coordination across the federal government and encourage collaboration with the private sector.
