



December Legislative Highlights RI Legislative Updates At A Glance:

Rhode Island is reporting COVID numbers the state had hoped to never see again, with case counts topping 1,000 some days and patient hospitalizations topping 200. That has left **Governor McKee** caught between his desire to avoid going backwards on COVID restrictions and the calls of many medical leaders to reimpose an indoor mask mandate. "Right now we're not ready to do that," McKee told reporters Thursday. "We're certainly relying on the people of the state of Rhode Island ... to personally make the right decisions for them in terms of their safety." (On Friday evening, the governor's office said McKee "will be announcing actions" to address the COVID situation "early next week," but offered no details.)

McKee primary challengers **Seth Magaziner**, **Nellie Gorbea** and **Helena Foulkes** all spoke out in favor of a mask mandate this week, while GOP lawmakers condemned the idea. The bigger question, hanging over not only the mask decision but pandemic policy more generally, is how the winter will go for the hospital system. Hospitalizations are still running at less than half their level of a year ago, but there is also a major staffing

shortage, meaning capacity isn't what it was a year ago, either. And the relaxation of mitigation measures that were in place last winter means other illnesses like flu and RSV are circulating more. Health Department data shows 96% of Rhode Island's 215 staffed ICU beds were occupied Friday.

National Legislative Updates At A Glance:

- **Updates on OSHA ETS:** OSHA's ETS remains Stayed by the Fifth Circuit until further judicial action. The various legal challenges to the ETS have been consolidated in the Sixth Circuit and DOL has filed a motion to lift the stay.
- Congressional Review Act: On December 8, the U.S. Senate passed a resolution under Congressional Review Act authority (S.J.Res. 29) to strike the ETS vaccine or testing mandate by a vote of 52-48.
- FTC Releases New Data, Public Service Materials on Gift Card Scams: This week, the Federal Trade Commission (FTC) reported data to alert the public, retailers, and other stakeholders that gift card scams are on the rise. The data showed that the amount of money lost by consumers to gift card scams in the first nine months of 2021 surpassed the total amount lost in 2020.
- AMS Declines Industry Request Regarding Unfilled Packaging and BE Rule: Last
 month a number of FBIA members, submitted a letter to the Agriculture Marketing
 Service (AMS) requesting additional flexibility with respect to the January 1, 2022
 Bioengineered Food Disclosure compliance date.
- FDA Releases Plan, Independent Review to Improve Foodborne Outbreak Response: On December 9, 2021, FDA released the Foodborne Outbreak Response Improvement Plan to "enhance the speed, effectiveness, coordination, and communication of investigations into outbreaks of foodborne illness."
- NYC Mayor Announces Vaccine Mandate for Private Employers: On Monday, New York City Mayor Bill de Blasio announced a vaccine mandate for private-sector workers in the city. The mandate, which is the first in the nation at the state or local level, will take effect on December 27 and apply to roughly 184,000 businesses.

Update to Vaccine Mandate Legal Challenges from NGA

The legal challenges to the Biden administration's private sector employer vaccine-or-test mandate have been consolidated and are now before the 6th Circuit Court of Appeals. OSHA will likely be precluded from enforcing the current mandate until the Supreme Court takes up the case and makes a final ruling, which could take until late January at the earliest.

Last year due to COVID the association did not have a PAC event and we did not solicit contributions as we had sufficient funds on hand and our strategy was to be very conservative with donations as it became clear that due to COVID there would be traditional fundraisers where you had the ability to attend and lobby those present. We had decided to do the same this year until we received a letter from the RI Board of

Elections, that noted a requirement (RI Gen. law 17-25) that we need to have 15 donations from individuals in an election cycle.

The association did, in the past 4 months, make three contributions for fundraisers for Senate Leadership, House Leadership and Rep. Bob Craven, Chair of House Judiciary, who has been an advocate and resource for our association for the past few years.

As a result of these donation from our PAC made this year and the need to be able to support those that have supported us next year in an election year, we are asking our members to please contribute to our fund so that we are in compliance with this regulation. We need to have at least 15 members make a donation of \$50 in order to accomplish this.

By way of review these checks must be personal checks and not corporate checks. In the past we asked for \$125 donations. If you could get two donations of \$50 from two different people, we would be able to achieve this goal. It should also be noted the if a personal check is from a joint account each person on the account can submit a separate check from the same account as long as they have two different signatures.
